THE BOARD OF TRUSTEES AND THE SENIOR DIRECTORS FILL OUT THE CONFLICT OF INTEREST POLICY ANNUALLY. THE EXECUTIVE COMMITTEE REVIEWS THE BOARD OF TRUSTEES AND THE PRESIDENT AND CHIEF EXECUTIVE OFFICER, AND THE PRESIDENT AND CHIEF EXECUTIVE OFFICER REVIEWS THE SENIOR DIRECTORS. MOST OF THE POTENTIAL CONFLICTS ARE ONES THAT HAVE EXISTED FOR YEARS AND WERE KNOWN WHEN, FOR EXAMPLE, THE BOARD MEMBER JOINED THE BOARD. NEWER POTENTIAL CONFLICTS ARE RAISED IF POSSIBLE BEFORE THE TRANSACTION OCCURS AND ARE DISCLOSED TO THE BOARD. SOME POTENTIAL CONFLICTS WOULD RESULT IN THE RESTRICTION OF THE TRUSTEE FROM DISCUSSION AND VOTING ON THE BUSINESS INVOLVING THE CONFLICT OF INTEREST.
